5:00 PM - 6:30 PM

THE MEETING WAS CALLED TO ORDER BY CHAIRPERSON, JANA CAVANAUGH AT 5:00 PM. ALSO PRESENT WAS ASSESSOR DEBRA LALLI. CHAIRPERSON CAVANAUGH STATED ASSESSOR DIANA KNAPP IS PARTICIPATING REMOTELY VIA TELECONFERENCING DUE TO REMOTE REASON #5, GEOGRAPHIC DISTANCE.

THE BOARD REVIEWED A COPY OF A WARRANT TO THE TOWN OF ROCHESTER FROM THR PLYMOUTH COUNTY COMMISSIONERS FOR FISCAL YEAR 2022 APPORTIONED TAXES IN THE AMOUNT OF TWENTY THOUSAND, FOUR HUNDRED, EIGHTY-TWO DOLLARS AND THIRTY-ONE CENTS (\$20,482.31)

THE BOARD ACKNOWLEDGED RECEIPT OF A NOTIFICATION FROM THE DEPARTMENT OF REVENUE STATING THE FISCAL YEAR 2021 PROPERTY TAX EXEMPTION FORM HAS BEEN APPROVED.

THE BOARD THEN APPROVED A FY 2014 PERSONAL PROPERTY TAX ABATEMENT FOR NEW CINGULAR IN THE AMOUNT OF ONE HUNDRED, SIXTY DOLLARS AND NO CENTS (\$160.00).

CHAIRPERSON CAVANAUGH OPENED DISCUSSION REGARDING THE LONGBOW SUBDIVISION WITH REGARD TO THE LETTERS TO BE SENT TO THE PLANNING BOARD AND CONSERVATION COMMISSION. ASSESSOR LALLI ABSTAINED FROM VOTING

CHAIRPERSON CAVANAUGH NOTED THAT SHE HAD INQUIRED WITH TOWN COUNSEL AS TO THE STATUS OF THE RIGHT OF FIRST REFUSAL DOCUMENT; WHO STATED THAT THE DOCUMENT IS READY FOR REVIEW.

ON A MOTION DULY MADE (LALLI) AND SECONDED (KNAPP) WITH ALL IN FAVOR; LALLI (YES), KNAPP (YES) AND CAVANAUGH (YES), IT WAS UNANIMOUSLY VOTED TO ADJOURN AT 6:30 PM
