THE MEETING WAS CALLED TO ORDER BY CHAIRPERSON DIANA KNAPP. ALSO PRESENT, ASSESSOR JANA CAVANAUGH, ASSESSOR SUZANNE SZYNDLAR AND ADMINISTRATIVE ASSISTANT MARGARET GONNEVILLE.

THE BOARD REVIEWED AND APPROVED PRINCIPAL ASSESSOR KAREN TRUDEAU TO ATTEND THE ANNUAL SEMINAR "WHAT'S NEW IN MUNICIPAL LAW" OFFERED BY THE DIVISION OF LOCAL SERVICES LEGAL STAFF.

THE BOARD REVIEWED, APPROVED AND SIGNED AN FY2023 WARRANT TO COLLECTOR FOR ROLLBACK TAXES ON PROPERTY LOCATED ON ASSESSORS MAP 46 LOT 24 IN THE AMOUNT OF FOUR THOUSAND, EIGHT HUNDRED, SEVEN DOLLARS AND SIXTY-NINE CENTS (\$4,807.69).
