BOARD OF HEALTH MINUTES June 15, 2022

MINUTES:

Ms. Dolan spoke to the Board about any Covid Cases in Rochester. She also ran a report before she came to the meeting and there are 12 cases in Rochester right now. There will be a meeting on August 11, 2022 regarding the State testing program for Covid. Danielle Cote would like to volunteer to help out with the vaccine clinics and Emergency Management Meetings. Policy regarding Covid — Even if you are unvaccinated you don't have to wear a mask anymore. They are re-formulating the vaccine to include the new strains. The Covid numbers are going down. This year for the tick borne viruses it is low as of now but there are a handful of cases. Socks or pants that are treated with prometherin to stop ticks should be worn.

DISCUSSION:

- 1. Season's Corner Market Failed System
 - They did a perc test and had to use a sieve analysis. They have just submitted the plans for approval. They are making a larger leaching field. What's there now for a septic system is under designed. They are adding a two compartment tank and a pump chamber.
