### **New Business**

### Snows Pond Association (SPA) Michelle Kirby President

Discussion on progress as well as concern regarding Pond Health in Rochester Snows Pond Association - Michelle Kirby

Concern of weeds growing in the pond are a great concern. She spoke to Laurel Farinon in Conservation in 2018 in regards to the ponds filling with sediment to the point they are not a pond anymore. Snows Pond and Mary's Pond Road are 20,000 years old and they need to be protected. They have been monitoring Snows Pond for 2 years now and it cost them \$10,000. Since the 2019 Survey she has been trying to do what she can. Michelle has gone to DEP workshops and other trainings. She has joined the University of RI water program that is \$700 dollars a year to save money with the URI certification. She personally delivers samples once a month. Phosphorus Nitrogen are tested. 2-2 1/2 years of testing and monitoring. Urinating in the pond increases the phosphorus rate. Nutrient pollution is the problem in the pond right now. Member Bailey has concerns that what they are doing is not a solution to the problem. Nick Kirby spoke to Member

Bailey about this. They would like to come together and make people aware. They are using herbicides. Member Bailey has concerns about the herbicides also. Upkeep is terrible but the alternative is worse. Member Bailey agrees with them about cleaning out the Pond but it will be quite the battle. Member Bache said he is with them 100% and they need some signs out there.

Leaching field is 100 feet from the pond. Chairman Gerrior asked if they know how many legacies there are. Nick Kirby spoke and said that some of the septic systems are bee-hives in the area of Snows Pond. Gerrior asked are there any authority that would tell them anything. Michelle said no. Chairman Gerrior said there are multiple agencies that do look at these things. Anti Barnacle campaigns and there are agencies that know about that. How does it compare, are some of them (ponds) going to dissolve tomorrow, Chairman asked. Which direction do we take, let nature take its

course or do we have man made control over them. Snows Pond has good water quality right now. Chairman Gerrior said to go with better practice and look at other advocacies. Once we've done that then we can go to the other departments to see if they can help and revisit this in maybe another year. Do a reasonable study Mr. Kirby said. Chairman Gerrior said that all of these questions and approvals seem to need to come from somewhere else. They have the Boards support. Find out who else can come in and help. Clerk Bailey said the time to start would be now. Michelle has the contacts but has not written a letter as of yet and was encouraged to contact other residents to create advocacies. Chairman Gerrior said that if they ever have anything they would like to present or share, they are welcome to come back to a Conservation Commission meeting.
