## SELECT BOARD MEETING FRIDAY, APRIL 15<sup>TH</sup>, 2022

Select Board Chair Bradford Morse and Vice-Chair Greenwood Hartley III are present. The Select Board's Open Meeting is opened by Chair Bradford Morse.

## **Select Board Signatures:**

Retail Liquor License: Change of Pledge for Llyod's Market: Costa's Family Market (dba Lloyd's Market) submitted a request for a change of pledge for their license due to a change in ownership of the building.

**Motion:** Select Board Member Hartley makes a motion to approve the application for pledge of liquor license for Costa's Family Market dba Lloyd's Market, located at 4 Hartley Road, as requested and to sign and send the approved licensing authority certification to the ABCC as the Local Licensing Authority. This motion is seconded by Member Morse. Both members of the Board are in favor, the motion passes.

The Board then reviews a copy of the proposed Annual Report submission for the Select Board.

**Motion:** Select Board Member Hartley makes a motion to approve the Annual Report submission as printed, seconded by Select Board Member Morse. With both members of the Board in favor, the motion passes with a unanimous vote.

After this, Town Administrator Cannon provides the Board with a draft contract for Jim Buckles to stay on as a part-time Building Commission on an interim basis during the transition of the incoming Building Commissioner. He also provides the Board with an update on the contract negotiations with Carl Bizarro for the Building Commission position, noting that they have hit a snag because he also holds additional employment teaching at New Bedford Voc-Tech High School. The Board note that they are okay with this and ask to include in his contract that they are okay with him holding both positions.

Motion: Select Board Member Hartley makes a motion to sign the employee agreement with Jim Buckles as presented, seconded by Select Board Member Morse. With both members of the Board in favor, the motion passes with a unanimous vote.

**Motion:** Select Board Member Hartley then makes a motion to put in Carl Bizarro's contract approval of him continuing to work at New Bedford Voc-Tech while taking the position of Building Commissioner. Select Board Member Morse seconds this motion, the motion passes with a unanimous vote.
